

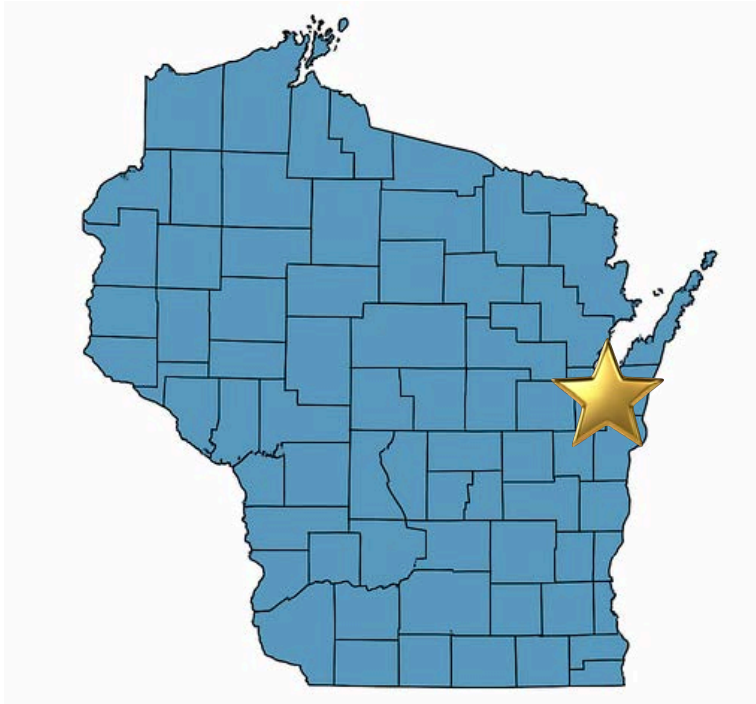

All residents are enrolled with an MCO, with the average monthly rate per resident at approximately \$5,831.
